The following claim is being submitted pursuant to RCW 4.96.020 and Bellingham City Charter Section 12.02.

1. Location:

Approximately the intersection of Hoff Rd. and Rural Rd. and the Whatcom County Jail.

2. Description of Conduct/Circumstances Which Brought About Injury:

Mr. Holmerud was involved in a motor vehicle accident at the above described location on April 14, 2010. Bellingham Fire Dept./Whatcom Medic One responded to the scene. The paramedics cleared Mr. Holmerud at the scene, and he was taken into custody by the Whatcom County Sheriff and booked into jail. The paramedics failed to recognize the fact that Mr. Holmerud's leg was broken, and an 81 year old man spent the night in excruciating pain until he was taken to the Emergency Room at St. Joseph Hospital the following day. The Hospital correctly diagnosed the broken leg.

3. Description of Injury/Damages:

Claimant has suffered the following injuries:

Negligence. Intentional Infliction of Emotional Distress. Medical Expenses. Pain and Suffering. Deprivation of Civil Rights.

4. Time and Place of Injury/Damages:

April 14, 2010. Approximately the intersection of Hoff Rd. and Rural Rd. and the Whatcom County Jail.






